- ❑ Removal of 1 chimney not in use
- ❑ Installation of GAF Timberline HD Birchwood Shingles
- ❑ Installation of new gutter system
- ❑ Full House paint
- ❑ HVAC tune up

NRLB Install 3 and NRLB Install 4 both hold the GAF System Plus Warranty

Safety Considerations

(Applicable to both NRLB Install 3 & NRLB Install 4)

- Complete fall protection necessary for all workers at all times.
- Securing of the jobsite to allow for the Installation Celebration (gathering of the community to support the homeowner who received the free roof).
- Providing separation of guests and installers during installation.
- Planned use of limited space for parking and worksite.
- Blocking off the street with barricades and road closure permit.



Unique Job Conditions

(Applicable to both NRLB Install 3 & NRLB Install 4)

- Homeowners had to be nominated through the No Roof Left Behind website and voted on by the community to receive the roofing system, as administered by Advanced Exteriors, Inc.
- Planning for and scheduling vendors and community members to attend the Installation Celebration.
- Provide a safe area for the community to gather adjacent to jobsite.
